Instructions to authors

Submissions should be submitted online via Manuscript Manager: ijes.manuscriptmanager.net. Proofs will be sent to the author once; the author is expected to read them carefully and return them promptly. The author may be charged for changes against the manuscript made by him/her in the proof.

Authors will receive a copy of the journal.

Manuscripts

Manuscripts must be typed on one side only of A4 paper, in 12pt font, double spaced, with wide margins. The text should be in a clear, concise style and written in English. Submission of the manuscript is taken to mean that the contents are original and that no similar paper will be submitted to another journal. Papers will be accepted for publication by the Editors on the advice of at least one referee. They should conform to the following layout:

(a) Research papers should not exceed 15,000 words; discussion papers should not exceed one printed page (approximately 600 words).

the main subject matter covered by the paper should be indicated by the title. should be given at the end of the paper, after the references. the main text.

(e) In the main text, use three or fewer levels of subheading. Metric measurements should be given wherever possible and abbreviated as 6mm, 4kg, 25km, etc. Names of taxa should be in italics. Illustrations and tables should be referred to as in the following examples: Fig. 7, (Fig. 7), Figs 7 and 8, (Figs 7, 8), Table 2, (Table 2). Footnotes will not be accepted.

(f) References should conform exactly with the examples given below. Journal titles should be given in full. Titles of books should also be given in full, together with the edition, place of publication and publisher. (g) Tables should be on separate pages and each should have a brief title. - (d) An abstract of not more than 200 words is required, which should be intelligible without reference to
